
### LIVING WITH A FOOD ALLERGY


Allergens continue to present a significant risk to our customers and our business as a whole. During the Allergen Awareness week last month, we shared a number of videos which highlighted what it is like for our customers and colleagues living with food allergies or having a child with a food allergy. Despite all the training, procedures and policies we have in place for the management of allergens we are still seeing a number of colleagues making assumptions or guessing what allergens are present in foods. ### VIOLENCE AT WORK

Across all our service sectors we are seeing an increase in the number of incidents reported which are related to aggression and violence towards our employees. This is clearly unacceptable, and we must ensure that both the physical safety and mental wellbeing of our teams is a priority. To support with this is is essential that all of these type of incidents are reported on AIR3.





To support you and your teams in managing the risk associated with work related violence we have the ES15 Violence at Work Risk Assessment. It is vital that this has been completed by the Unit Manager and is part of the unit's WSMS folder. There are also two Safety Task Cards, STCSSI 24 & 25, that must be used to train teams. Please visit the WSMS Page on the <u>HSE website</u> to download these. Some sectors may have additional specific training in dealing with this, so please check with your sector HSE Team.

### **STAY SAFE WHILE USING E-SCOOTERS & E-BIKES**

E-scooters and e-bikes have been a very popular way for people to get around. Although most are manufactured to very high standards, there are unfortunately safety issues related to these forms of transport. Read our advice on how to stay safe. There are two types of batteries for these, Lithium-ion (Li-ion) or Nickel-metal hydride (NiMH). Li-ion batteries, which are most common, can overheat and potentially catch fire if damaged or mishandled. There have been a number of fires recently caused by e-scooter and e-bike batteries, especially related to thermal runaway. Li-ion batteries are at risk of thermal runaway, which is when a battery overheats and can't stop getting hotter, potentially resulting fire or explosion. If using these in the workplace refer to STCGE52 Bikes, e-bikes and e-scooters.



### **RoSPA Advises**

- Charge properly. Always use the charger supplied by the manufacturer, and disconnect the charger once charging has completed.
- Check for battery damage. If the battery has 'swollen', smells unusual or shows signs of damage, stop using immediately
- Store and charge safely. Do not charge é-bikes and e-scooters near to 'escaperoutes' in your home or anywhere else you charge.
