3 LIMITATIONS AS TO USE

- A Use for business purposes by any person to whom the vehicle is let on hire by the Insured
- B Use for agricultural and forestry purposes
- C While the vehicle is being so used the carriage of passengers other than for hire or reward is permitted
- D While the vehicle is being so used the carriage of passengers is permitted
- E Use for the carriage of passengers for hire or reward
- F Use for hire or reward
- G Use for racing pacemaking reliability trial or speed testing
- H Use while towing any one disabled mechanically propelled vehicle
- J Use while driving a trailer
- K Use while drawing one super-imposed trailer being part of an articulated vehicle or one disabled mechanically propelled vehicle
- L Use while drawing more than one trailer but not a greater number of trailers in all that is permitted by law

4 PERSONS, OR CLASSES OF PERSONS, WHOSE LIABILITY IS COVERED

- M Any person to whom the vehicle is lent or let on a hire by the Insured
- N Any person to whom the vehicle is let on hire by the Insured but only in respect of the negligence of the Insured or any other employee of the Insured
- O Any person to whom the vehicle is let on hire by the Insured
- P The Owner of any vehicle described in 5(1) opposite

6. DRIVERS, OR CLASSES OF DRIVERS, WHOSE DRIVING IS COVERED

- R The Insured
- S Any person between the ages of 26 and 65 years inclusive who is driving on the Insured's order or with the consent provided such person holds or has held a Licence (other than a Provisional Licence) to drive such vehicle
- T Any person referred to specifically in 6(3) overleaf who is driving on the Insured's order or with his consent
- U Any person driving with the consent of a person to whom the vehicle is let on hire by the Insured
- V Any person to whom the vehicle is let on hire by the Insured
- W Any person who is driving on the Insured's order or with his consent
- X Any person between the ages of 26 and 65 years inclusive who is driving on the Insured's order or with his consent
