Safe System of Work

- 1. Only use equipment if you have been trained to do so. Follow the manufacturer's instructions where these are available.
- 2. Before use, check that the emergency stop button and the automatic cut out are in working condition.
- 3. Check that the switch is in the off position before plugging equipment in.
- Make sure all cabling is stored away safely behind the equipment and is not causing a trip hazard.
- Check that the equipment is stable and level.
- Ensure the appropriate fixed LEV or portable dust extraction system is selected/attached before use.
- You must wear safety goggles and hearing protection when using the thicknesser.
- Gloves should not be worn as these can be pulled into the equipment.
- Loose clothing and lanyards must be contained within your overalls, long hair must be tied back, and any jewelry removed.
- 10. Keep fingers and hands away from the machine opening.
- 11. Stand to the to the side of the opening to avoid kickback.
- 12. Long lengths must be supported from the end to avoid undue strain on the blades and then held while it is fed out of the other side.
- 13. Only use the thicknesser for solid wood. It must not be used for plywood or any man-made material.
- 14. Check material before and do not insert any material containing screws, nails or other metal objects, or loose knots.
- 15. Do not insert work that is shorter than the minimum permitted length. This is determined by the configuration of the equipment.
- 16. If the piece of work is tapered, the thicker end should be inserted first.

Safe System of Work

- 17. Only insert one piece at a time.
- 18. Do not grip work from the bottom, but from the side or top to prevent fingers being pinched between work and the equipment surface
- 19. Allow the thicknesser to control the speed work is processed; do not push or pull work into or out of the equipment..
- 20. If work becomes jammed, turn equipment off and lower the table to release the work. Adjust the machine and then continue.
- 21. Leave the area clean and tidy and dispose of any waste materials using the correct site procedures.
- 22. Report to you manager if you feel any numbness or inability to feel temperatures during or after using the equipment, or if you experience any hearing loss symptoms.
