All officers to wear: stab vest, safety boots, body protection - suitable for task, hi-vis vest/coat in poor visibility

# Safe System of Work

#### Dynamic risk assessment of situation

- All officers to be trained in lift release and rescue and able to determine if safe to proceed for both trapped and rescue personnel - rescue to be controlled and led by senior duty manager to check at all stages safety is being controlled and if patient medical practioner present to monitor patients' wellbeing and vitals.
- All officers to hold SIA licence.
- Ensure communication to main security office is working and maintained and be ready to escalate to emergency services if deemed risk has increased.
- Cordon off any area that is a risk to other users and ensure clear guidance on alternative route or spaces if needed.

#### **Preventing falls from heights**

- Officer to not enter lift shaft at any time.
- Lift doors to be opened to a minimum amount to allow egress of trapped person.
- Do not allow others to enter the lifts.

## Preventing impact /crushing injuries

- Officer to not enter lift shaft at any time.
- Officers to adhere to warning signage related to moving mechanisms with the lifting machines engineer to be present and to have locked off the lift to prevent accidental release or movement during release.

# Manual Lift release and lift rescue

# Safe System of Work continued

- Confirmation the system has been locked off and cannot be turned back on remotely. This to be confirmed prior to any attempt to release the trapped person and during the rescue.
- Senior Duty Manager controlling the rescue to be in contact with all parties involved and be responsible for halting the process if at any time they have concerns or feel situation needs to be addressed by emergency services.

#### **Avoiding conflict**

- All officers to be trained in personal safety in workplace, conflict management and incident de-escalation with assignment instructions documented.
- Be aware the trapped person(s) may be upset/aggressive/scared. Officers will need to deal with the emotions accordingly using deescalation techniques.

#### Manual handling

- Use correct lifting techniques to support any equipment removal.
- If personnel require support complete under medical supervision to prevent injury to officer and person being rescued.
- If at any time the rescue is deemed unsafe for officers or person being rescued, revert to keeping calm and keeping the person being rescued calm with communication while the emergency services are contacted.
