

What are the hazards and how might they harm?



Exposure to extreme Exposure weather conditions

Safe System of Work

Patrols internal and external:

- Always use the footpath and demarked areas when traveling across site.
- Any vehicles speeding above gareed site limits should be reported.
- Ensure correct footwear, PPE and hi-visibility clothing is used.
- Ensure that safety boots are worn and checked regularly for damage or loss of grip.
- Ensure that all footpaths are even and report any defects.
- Use a flashlight to assist in any darkened areas.
- When the weather warning suggests the risk of ice, ensure this is reported to the client/facilities/property team to have the site gritted.
- If securing off site route to be agreed and documented. Any concerns to be reported to line manager.
- Lone working to be avoided and external patrols during unsociable hours to be in pairs.
- Key control to be enforced REF Security SOP20 Keys.
- Ensure both torch and radio fully charged and in good working condition prior to commencing patrol.

Intruders

- Be calm, and if the individual displays aggression, report this via the escalation route and seek assistance from the local authority.
- Please refer to Intruder Incident & Investigation Safety Task Card

Adverse weather

- Appropriate clothing to be provided to protect from adverse weather conditions; suitable sturdy footwear to be worn at all times.
- Ensure exposure time is minimal.
- Wet weather gear to be worn in the rain; this must be removed immediately once inside.
- For further information please refer to the HSE website "Temperature".

Hot weather

- Ensure there is a suitable provision of protection from the sun in the form of sun protection products and job rotation when having to work in direct sunlight.
- Ensure access to adequate water supplies to avoid dehydration.
- To reduce risk of overheating remove stab vest upon returning to office until required for next call out/patrol.
- Ensure you are hydrating and have access to fresh air, and use a fan or air conditioning system to reduce body temperature.

Safe System of Work continued

Access to restricted plant rooms and external roof areas

- All officers to carry radio with man-down function and alarm and notify control when entering plant rooms or accessing roof areas.
- Site authorisation permit to be completed before entering any restricted area including escort of contractor personnel.
- All operating RAMS to be signed by the issuing department controlling the area being entered.
- Officers to be trained in the correct PPE including harness and lanyard usage.
- Records of maintenance of anchor points and harness condition to be viewed monthly by security manager to ensure they are safe for officers to access.
- Officers to confirm with Hard FM or control for area being accessed any specific hazards the officers need to be aware of prior to access.
- Radio contact to be maintained with 15-minute intervals being observed. In the case of failure to report every 15 minutes, shift leader to immediately investigate situation and organise appropriate actions.
- Emergency procedure must be in place and regularly reviewed in event of incident and all shift team aware of process to follow.
- Any key control process or lock-out system must be completed by trained operatives prior to entering area and ensuring area is secure on exit and keys logged back into control.
- If entering a construction area all officers must report to site foreman prior to entry for briefing of safety controls in the area including any additional PPE (head protection/harness).
- No access to restricted/roof areas to be permitted in poor weather conditions or low light if access required in emergency, major incident plan to be followed)
- Report any equipment faults and hazards observed during patrol so this can be escalated record on the daily
 occurrence log.
- Restricted access to sensitive areas such as mortuary; gain authorisation prior to entering the area.
- You must follow the medical team on approach and use restraint if required.
- Do not engage with assailant with weapon retreat to safe distance to observe and contact police to attend. Prevent others from accessing area.
- Do not leave the hospital grounds during shift without prior authorisation
- Do not take responsibility for patient, visitor or family/contractor personal belongings or equipment at any time.
