3 LIMITATIONS AS TO USE

- A Use by the Insured in person in connection with his business or profession
- B Use for the Insured's business
- C Use for professional purposes by the Insured and/or by any partner, employee, locum tenens and/or assistant of the Insured
- D Use for the purpose of the Insured's business as a Farmer (which term shall be deemed not to include a Nurseryman or a Market Gardener (including the conveyance of goods in connection with such business but excluding use for house-to-house retail distribution)
- E Use by the Insured in person for the purpose of his business (other than that of a Farmer) but excluding the carriage of goods or samples in connection with such business
- F Use for the purposes of the Insured's business but excluding the carriage of goods or samples in connection with such business
- G Use (but not driving) by the Insured in person in connection with his business or profession
- J Use for commercial travelling
- K Use for the carriage of goods or samples in connection with any trade or business but not for commercial travelling
- L Use for carriage or passengers for hire or reward

4 PERSONS, OR CLASSES OF PERSONS, WHOSE LIABILITY IS COVERED

- M The Insured's employer except so far as the Policy relates to any vehicle belonging to such person
- N The Owner or any vehicle described in 5(1) overleaf
- O Any person to whom the vehicle has been let on hire
- P Any partner, employee, locum tenens and/or assistant of the Insured

- U Any person who is driving on the Insured's order or with his consent
- V Any person between the ages of 26 and 65 years inclusive who is driving on the Insured's order or with his consent
