Safe System of Work

1. All staff must complete the site-specific Event Site Induction and sign in and out every day.
2. Familiarise yourself with the evacuation routes and location of first aid facilities and fire fighting equipment.
3. Where there is a site safety board at the entrance to the site, this should be checked daily for any updates.
4. Reinforced toe-cap safety shoes and a high vis vest must be worn at all times. Additional PPE, such as hard hat or traffic gloves, must be worn in line with site rules or when performing specific tasks.
5. Wear appropriate clothing for the weather conditions and take regular breaks in a warm area and have warm drinks in cold conditions, and in a cool or shaded area and have cold drinks during hot weather.
6. Hours of work are limited to daylight hours; any work outside of these hours must be authorised by your manager.
7. Be aware of vehicle movements in particular plant machinery and heavy goods vehicles with restricted visibility. Always keep to walkways and behind barriers where these are provided. Look both ways before crossing any vehicle routes and avoid crossing in corners or where there is poor visibility.
8. Only carry out tasks and use equipment that you have been trained to do/use and follow the safe systems of work including manual handling practices in the relevant Safety Task Card or Risk Assessment.
9. Use available mechanical manual handling aids wherever practicable.
10. Keep the site tidy. Ensure all goods and tools are stored correctly and safely and dispose of waste material in the appropriate bins/skips.
11. Never enter any structure that is incomplete or deemed unsafe. This includes any structure where there is no edge protection, where stairways are incomplete, or where side walls are missing.
12. If you observe any unsafe behaviour by you colleagues or by anyone else on site, report this to your manager.
13. All incidents/accidents must be reported to Event Management.

If you have any concerns, stop and speak with your line manager before proceeding.
